2. Compliance of the points no. 1 to 8 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

Sl. No.	CONDITIONS FOR COMPLIANCE
1	The total number of section of the school shall be restricted to 24 on the basis of running classes and additional classroom reported by the school and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2	The CWSN toilets shown in the RC video is not disabled friendly. The school is directed to fix the handles/support and make the entry barrier free so as to enter wheel chair inside the toilet. The provisions laid down in RPWD Act may be followed to make the facilities disabled friendly and submit the compliance.
3	There is no partitions in boys' urinals. The school is directed to fix partitions and submit the compliance.
4	The school must ensure provision for CWSN such as ramp at the entrance, ramp / lift to access upper floors and separate toilets for girls and boys on every floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD.
5	The school shall conduct training of its teachers with CoE Chandigarh within 3 months and submit the compliance.
6	The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.
7	The school shall get all the mandatory certificates renewed periodically.
8	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
